T.R.C.P. Rule 176 AND 201

Enforcement of Subpoena: Contempt Failure by any person without adequate excuse to obey subpoena served upon that person may be deemed a contempt of the court from which the subpoena is issued or a District Court in the county in which the subpoena is served, and may be punished by fine or confinement, or both.
